



Initiative Measure 1631: YES

yeson1631.org | This carbon fee initiative is a practical first step to address the urgent issue of climate change, to reduce pollution, and to ensure clean air, clean energy, and clean water for our state. I-1631 centers environmental and economic justice, investing directly in low-income communities and workers impacted by a transition away from fossil fuels.

Initiative Measure 1634: NO

no1634.org | I-1634's big corporate donors in the soft drink industry would have you believe this initiative is about keeping groceries untaxed and affordable, but most groceries in our state are already exempt from sales and use taxes. This initiative is a sneaky attempt to prevent more cities from exercising local control and adopting a tax on sugary beverages. Don't fall for it.



Initiative Measure 1639: YES

yeson1639.org | 4.6 million American children live in a home with a loaded, unlocked gun; secure storage incentives and firearm safety training requirements can keep kids safe,

reducing suicides, unintentional injury, and death. I-1639 also brings semi-automatic assault rifle purchases in line with our state's handgun requirements, reducing firearm homicide risks.

Initiative Measure 940: YES

deescalatewa.org | This initiative reforms our criminal justice system by training police on violence de-escalation, mental health, and first aid; removing de facto immunity for use of deadly force; and requiring independent investigations of police violence. The legislature did pass it, but a Tim Eyman lawsuit means the people must vote on it again.



Advisory Vote 19:

E2SSB 6269: **MAINTAINED**

advisoryvotes.org | Every time the Legislature raises or recovers revenue, Tim Eyman's I-960 requires an advisory vote. Advisory votes are non-binding, will not change state law, use biased language, and give Eyman leverage to stand in the way of a functional government. Protest Eyman and vote to maintain this bill.

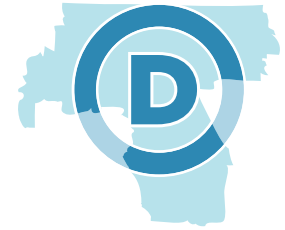
